# Membership Funding for BIPOC Library and Archives Students & Workers

As a chapter of the Association of College and Research Libraries (ACRL), the Michigan Academic Library Association (MiALA) ascribes to the ACRL core commitments as outlined in their <u>Plan for Excellence</u>. This includes the core commitment to "...acknowledge and address historical racial inequities; challenge oppressive systems within academic libraries; value different ways of knowing; and identify and work to eliminate barriers to equitable services, spaces, resources, and scholarship."

Recognizing that the COVID-19 pandemic has further exacerbated deep-seated inequities within librarianship and society as a whole, particularly impacting library workers and students who identify as Black, Indigienous, and People of Color; and in support of the precedent set by ACRL in creating their <u>ACRL Funding for BIPOC Library Workers</u> initiative, the MiALA Inclusion, Diversity, Equity, and Accessibility (IDEA) Committee proposes the following:

- 1. The creation of a Membership Funding for BIPOC Library and Archives Students and Workers Initiative. The initiative would fund 10 MiALA student membership and 5 MiALA library/archives worker memberships for the period of one year (2021-2022).
- 2. The creation of a lightweight application process that sets the same prioritization structure for granting membership funding as outlined by ACRL, which is listed below:
  - students/workers who experienced household job loss, income loss, or furlough during 2020;
  - are students and/or early-career library workers (having less than 5 years of experience)
  - currently serve, have served, or will be serving underrepresented populations at academic, college, or research libraries or institutions, including junior, community, or technical colleges; vocational institutions; rural institutions; Historically Black Colleges and Universities (HBCUs); Tribal Colleges and Universities (TCUs); and etc.;
  - are new to MiALA

The IDEA Committee expects the announcement and application process to go live on May 1st, 2021, with a closing date of May 31st, 2021. This would allow the committee to review applications and make decisions by June 18th, 2021, allowing for membership for all selected applicants to begin July 1st, 2021. This initiative will be revisited by the 2021-2022 IDEA Committee to determine its financial sustainability and efficacy in supporting our BIPOC library colleagues in engaging meaningfully with MiALA.
